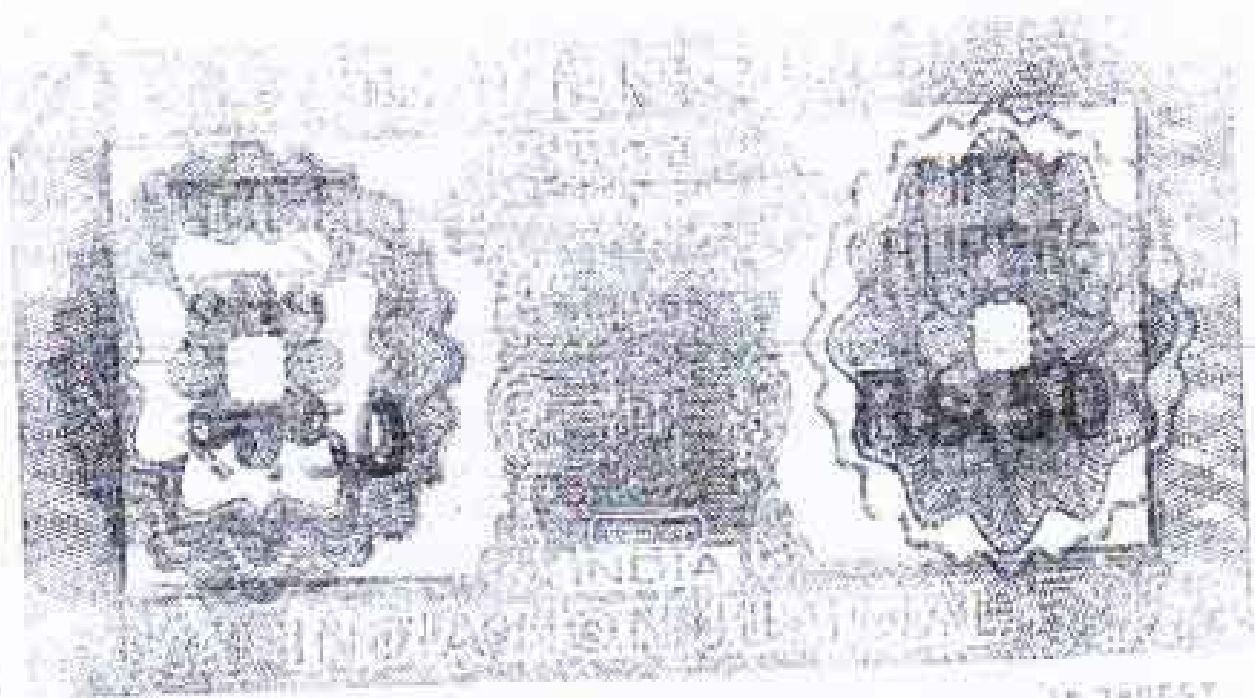

 - (b) To give Scholarship , Prizes, Awards, Loans or other assistance.

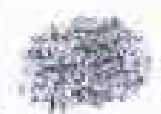
